In Turkey, prisons have always been at the center of human rights violations. The same unlawful approach has been taken against all prisoners. However, there has been systematic unlawful and abusive treatment of dissidents, especially against the Kurds.

The reflection of the country's democratic standards was first felt in prisons. Dissidents were wanted to be silenced by antidemocratic methods by filling prisons and increasing repression and mistreatment in prisons.

Recently, especially after 2016, these practices reached their peak and the number of people held in prisons reached a record high.

According to DW's report<sup>1</sup>, imprisonment rate per capita is the highest in Turkey.

The number of people in Turkish prisons has not only broken its own record, but has reached the highest figure among the members of the Council of Europe<sup>2</sup>. New prisons have been built, and the most basic rights of prisoners and prisoners have been restricted under the name of high-security prisons. This situation was noted in the reports and statements of many human rights institutions, bar associations and non-governmental organisations<sup>3</sup>.

## **Preparation of the Report:**

We needed to conduct a study in this field in case of an increase in allegations of rights violations in prisons in Turkey. In this case, based on the news in the media, the Turkish Association for Human Rights, the Free Lawyers Association, the Association of Solidarity with Detained Families, the Turkish Foundation for Human Rights, etc. The reports on the websites of their institutions, the interviews we have had with some detainee families and the information we have received in the media have raised our concerns that there are serious human rights violations in Turkish prisons.

#### **Torture and Bad Treatment :**

Physical attacks on inmates, threats, beatings, nude searches, torture and illtreatment through dominant cell searches, racially discriminatory approaches, threats to death, police enter cell searches with guards, forcing political prisoners to move to the independent ward, forcing them to stand in one row in the military order, violations in the field of health and treatment rights, arbitrary prohibitions and practices have continued to increase. Inmates who could not find an interlocutor to solve their problems were forced to go on hunger strikes and death fasts against unbearable rights violations.

Under the pretext of the COVID-19 pandemic, restrictions on all social rights in prisons continued and isolation and isolation deepened. Due to appointment cancellations, handcuffed examinations and adverse quarantine practices during the Covid pandemic, hospital referrals and problems in accessing treatment have become more important with increasing patient prisoner deaths in the recent period.

One of the most intense problems during this period was the practice of nude search and the desire to look inside the inmate's mouth during the search. Inmates who refused to search naked were tortured, their clothes were torn apart and forcibly removed, inmates were asked to kneel, and inmates who refused to accept it were tortured beyond physical assault. In addition, the inmates were sued for resisting the officer in charge, and the complaints made by the inmate were answered "there is no room for prosecution" and the files were closed.

As we mentioned above, the pandemic process has transformed the practice of isolation in prisons into a more common and severe form; The right to chat sports, which allows him to communicate with other inmates, has been completely eliminated, and his ties to the outside, including his family and relatives, have been severely weakened. This situation eliminated not only the socialisation of the prisoner, but also social solidarity, cultural development, understanding what was going on outside, access to intellectual tools and information to improve himself, and severely isolated and isolated the prisoner from the outside. The conditions of severe isolation applied in Imrali prison continued and isolation practices were widespread in other prisons.

Disciplinary penalties, timely publications and book bans and letter bans, failure to send articles and criminal complaint petitions to official institutions, the lack of use of chat and sports rights, their inability to adequately use cell ventilation, exorbitant prices in prison canteens, lack of variety, the presence of only certain

brands, the prohibition of the sale of certain necessities in the canteen and the fact that these needs are not met from the external canteen continues. it's a good place to be Problems with nutrition cause prisoners to not eat adequately and healthily during the Covid-19 pandemic. Another problem is that execution guards and managers are constantly straining the environment with profanity and insulting abuse of inmates. Hostile behaviour and arbitrariness to prisoners has reached an extreme level.

Failure to take covid-19 measures in cell searches, raiding cells, requesting night cell searches, twice a week cell searches, entering police and intelligence officers dressed as guards with guards, breaking up, distributing items, raiding cells by targeting individuals, problems with family and lawyer opinions, restrictions on receiving visitors to the opinion, the ability of the person to see new challenges have also been introduced, such as the requirement and the requirement that the person who will come to the opinion notify him or her that he/she will arrive some time before he arrives.

Another problem is that prisoners are constantly pressed into cells and taken to other cells against what they call internal exile. Again, the scribble of the letters sent by the prisoners, the request for a petition to allow the scribble of the inmate, the sending of even urgent letters after a month, the failure to send faxes, the obligation to stamp the letter sent to the prisoner, the fact that the letter sent to the same person in the same cell is not allowed to be sent in the same envelope, the cartoons contained in the letter sent by the prisoner to another prison friend are deemed objectionable months later. The return of prisoners from the prison where they were sent, the collection of radios that the prisoners received with their own money, the interruption of the television broadcast, the failure to give metal tablespoons to the prisoners, the collection of existing ones, the giving of a plate to three people, the under-

## **Suspicious Deaths in Prison:**

After the coup of July 16, 2016, there were also increased pressures in Turkish prisons and increases in deaths due to diseases, suicides and similar necessities. There are serious couscous in official explanations in the deaths in prisons.

giving of meals, the continuous delivery of the same meals, continues.<sup>4</sup>

In the first 3 months of 2021, it was determined that 12 prisoners had died. Six of these inmates died of suicide, four died of Covid-19, one died of chronic disease, and one died suspiciously.

**Sinan Kaya:** 20 March 2022 - 28 years old, died in Igdir S Type prison suspiciously. Sentenced for 3 years for propaganda of organisation. He had 28 months left to be released.

**Can Güder:** 22 March 2022 - 20 years old, died in Van F type prison suspiciously. He had no any disease recorded.

**Erdal Kilinc** : 12 May 2021 - An inmate named Erdal Kilic, who was held in Istanbul Silivri Prison, died of Covid-19. –

**Serif Vatansever** : 16 May 2021 - Serif Vatansever, held in Kocaeli Type 2 Prison, has died due to Covid-19.

**Mehmet Ozen** : 5 August 2021, it was learned that Mehmet Ozen (37), who was held in Burdur E Type Prison and released after suffering a brain haemorrhage on July 25, 2021, had died.

**Cenk Sari** : 5 August 2021, it was learned from the media reports that Cenk Sarı, an inmate held in Antalya E Type Prison, died of a heart attack.

**Mehmet Ali Celebi** : Mehmet Ali Çelebi (70), a prisoner who was released from Xinjiang Prison in Ankara, where he was held on August 25, 2021, died on September 4, 2021 at Çam Sakura City Hospital in Istanbul, where he was being treated.

**Kenan Ozcan** :22 September 2021, it was learned from media reports that Kenan Ozcan, who was being held in Afyon Bolvadin Type C Prison, was taken to Eskisehir City Hospital on September 17, 2021 and died on September 20, 2021.

**Halil Gunes** : He is on the human rights association's list of sick prisoners, was arrested on January 2, 1993, received a suspended vertebrae prison sentence and spent 29 years in prison. In 2014, the Diyarbakir Gazi Yasargil Training and Research Hospital reported that he could not be 'imprisoned' for Halil Gunes, who was diagnosed with lung and bone cancer, while the Judicial Type Agency prevented his release by saying that he could "live his life alone and remain in prison". In 2014, the lawyers were denied an application to the Constitutional Court to 'stop his treatment' in order to improve his illness.

Halil Gunes was found dead at his prison cell on December 15, 2021. Halil Gunes, who was placed on a one-person hucre five days ago, was allegedly not given the drug in recent days.

**Garibe Gezer** : In type F of Kandira 1, Garibe Gezer, who announced the crime by stating that he had been tortured and subjected to sexual assault by execution guards, was informed to her family that he had committed suicide on December 10, 2021. Garibe Gezer, a 28-year-old Kurdish woman from Nusaybin, has been sentenced to prison for political reasons. When she is transferred from Kayseri Bunyan Prison to Kandira F type prison, he informs HDP MP Omer Faruk Gergerlioglu that she has been tortured, harassed and incarcerated in Kandira prison. The HDP Women's Group presents the situation to the ministry of justice on October 25, 2021 with a question-and-answer 22 questions. In Omer Fark Gergerlioglu, he brings the day to the parliament. However, questions are not answered by the Ministry of Justice.

Since Garibe Gezer wants to convey the situation to lawmakers and his family, a one-man hucre is put on a cell for 22 days. After the one-person person has left the cell, he is shown to have passed the situation to his family by phone and put her in the padded room. The prison administration has informed his family that he committed suicide in the padded room. His lawyers and HDP lawmakers say the suicide is suspicious and that the claim that she may have been killed is strong. The fact that his autopsy did not have her family and lawyers and that it was done in secret reinforces this claim.

**Abdulrezzak Sur** : Abdulrezzak Sur, 56, who was on the human rights association's list of heavy sick prisoners in Izmir Aliaga Sakran T Type prison, died on December 14, 2021. In 1993, Sur was sentenced to a vertebrae-length prison sentence. In 2006, the European Court of Human Rights ruled that Abdulrezzak Sur had been infringed on in violation of a few rules and demanded a retrial. However, the Turkish courts did not implement the decision. Abdulrezzak Sur, who is a patient of asthma, was diagnosed with lung cancer three months ago. He was given a wish by his family to be treated outside, but there was no answer. Media reports and his family claim that after the illness was diagnosed, his treatment was not carried out in prison. He died on December 14, 2021.

**Vedat Cem Erkmen** : A prisoner named Vedat Cem Erkmen, who was sentenced to life in Tekirdag Type F prison, was found on December 19, 2021. The prison service called his family at 9 p.m. to report that he had committed suicide. Vedat Cem Erkmen's autopsy was performed without his family and lawyers. In the face of the request of the member's family to be sent to the Istanbul Digorians Association and the funeral ceremony, Vedat Cem Erkmenin's body was taken by the police, given to his family in Sakarya province, 155 kilometres from Istanbul, and told to go to Kars, otherwise they would not see it themselves. After their lawyers' interviews with the inmates in the prison, they made it very important that the death of the Man was suspicious and that he may have been killed.

**Turgay Deniz** : Turgay Deniz, a patient of tuberculosis in Metris Prison, was not released despite doctors declaring that he could not stay in prison. After collapsing in prison and being hospitalised, he died in hospital on 2 February 2022 from insufficiency.

**Mehmet Hanifi Bilgin** : A Kurdish political prisoner registered in the Bingol population who was arrested while he was a student. Bolu was sentenced to life in Type F prison and five months before his release, his family was informed that he had lost his life as a result of a heart attack. M. Hanifi, who suffered a heart attack three years ago, would have been released in five months if his execution had not been carried out.

**Ercan Eke** : Muslu has been imprisoned for 13 years due to a criminal case. He was pressed by his family for letters to those detained for political reasons and explained to human rights organisations. Despite his sentence, he was not released due to disciplinary action. On March 5, 2022, his family was notified that the foot slipped and fell to the ground, and there were signs of impact on the bass. His family said his death was suspicious.

**Sick and Extremely sick Prisoners that are in Critical Conditions:** The biggest recent infringement is the failure to treat sick prisoners and their deaths in poor conditions by not being released. Although hundreds of detainees and prisoners are documented in the report of medical institutions that they are seriously ill, they are not treated and are not released, leading to a de facto death penalty. It is stated that there are nearly 1500 sick prisoners and prisoners who are incarcerated or convicted of various crimes.<sup>5</sup>

Partial information is available about 650 people whose condition was determined by the health report. It is extremely difficult to get healthy

information, especially since prisons are closed to opinions on corona grounds. Again, due to the frequent deportation of prisoners and detainees to different prisons, they do not have the opportunity to communicate outside and to receive regular treatment.

## Through a few concrete examples, we can further state the condition of the sick prisoners:

**Mehmet Emin Özkan**, 83 years old, was arrested in 1996.Mehmet Emin Özkan, who spent 26 years in prison in 1996, suffered numerous illnesses, suffered 5 heart failures and had angio 4 times. In 2015, 87 percent of ozkan was seriously ill and could not remain in prison.

Ozkan has changed six different prisons so far and still has more than 10 severe illnesses. Unable to meet the needs of eating, drinking, dressing and bathing in the prison, Ozkan is trying to continue

his life with the help of his son Ahmet and other detainees who are being held for another crime.

His trial is scheduled for March 17, 2022.



**Siddik Guler**, 82 years old, lives in a wheelchair due to diseases such as hypertension and inflammatory arthritis. Guler, who also has a heart condition and has been in prison for 27 years, was denied parole and it was decided that it was ok for him to remain in prison.



**Aysel Tugluk** was arrested on 29 December 2016, while serving as HDP Co-Chairman. The indictment against Tugluk accused him of his statements and activities during his time as Co-Chair of the Democratic Society Congress (DTK). Announcing its decision on March 16, 2018, Ankara announced its 17th president. The Criminal Court

sentenced Aysel Tugluk to 10 years in prison for allegedly "being the part of the administration of the organisation".

Despite the objections, the Supreme Court ruled in the 16th century that the 16th Circuit court of appeals should not be held in The Department of Corrections also upheld the prison sentence for Tugluk.

An arrest warrant was issued for Tugluk as part of an investigation by the Ankara Public Prosecutor's Office into the October 6-8 Kobane actions.

In the July 12, 2021 report prepared by the Head of the Department of Forensic Medicine of Kocaeli Faculty of Medicine, "... there may be problems with the adequacy of medical support and care that can be provided to the person in prison conditions, it is not possible to live his life alone without the help of someone else, he cannot meet his mandatory needs without the help of another in prison conditions, so the execution of his sentence should be postponed."

Several human rights organisations and international institutions have demanded the release of Aysel Tugluk. He is currently a prisoner in Prison No. 1.

## **Exclusion from Paroles, the Prevention of Releases:**

One of the most problems in prisons has been the deprivation of these rights in the name of 'good behaviour' assessment of prisoners who have been released or need to go to an open prison.

The 'Prison Administration Board', which has been expanded with the carving published on 31 December 2020, can prevent evictions due to the need for 'good governance'.<sup>8</sup>

Detainees are being forced to be detained through the board of custody. The detainees' interviews, letters, books they read, wishes written, arbitrary disciplinary penalties and the decision not to go to the independent ward are prevented from being released by the detainees as they are not 'well behaved'. Torture and bad treatment, swearing, insults, threats, spying and standing military counting, disciplinary penalties being used as a threat, cell penalties, and attitude against attacks such as sniping can be necessary to exclude from parole. Urgent disciplinary proceedings and social media postings before arrest can be used as a necessity to deny parole.

staying in the ward of organised prisoners is not well-behaved, the persons who comes to the detainee, who deposits money, who celebrates or commemorates, etc. are subject to good behaviour assessment and the release of the detainees is prevented. In Sincan Prison, the female political prisoner was sentenced for singing and stillborn, and their release was postponed.

Although his sentence ended on July 13th, the Criminal Court overturned the decision after the prosecutor's office objected to the Execution Judge's decision that he should benefit from probation.

28	Bazi Bór	Bazi Bor was arrested in 2010 at the age of 60. He was sentenced to 19 years and 6 years, then reduced from 4 1/2 years with the abolition of special competent courts. Since 2010, the prisoner was supposed to be released on November 24, 2021, but after a meeting with his lawyers, he will be held for another six months. Some Bor is sick, old, has chronic diseases as well as herniated discs, has undergone two surgeries during his time in detention, has severe migraine attacks and suffers from asthma.

Mizgin, who is imprisoned in The Shakran Women's Closed Prison, was supposed to be released from probation as of November 17th, but his execution was burned after an interview by the Administrative and Monitoring Board suggested he was not "well behaved." Mizgin said that the prison prosecutor, who chairs the Administrative and Monitoring Board, asked him, "Will you join the organization when you leave", and asked him to declare that he had abstained. He said remziye's statement was affixed to Mizgin's statement. "They're do cut-and-paste," he said. The client's going to have a hard time proving what he didn't say. So not everyone can say the same thing in front of that committee. It is also understood that the statements of the individuals did not go into one-to-one minutes."

83	Aydin Elci	He has been in prison for 30 years in Bandirma E tIpi prison. Although his sentence is over, disciplinary proceedings are not required and he is not released.
84	Cetin Arkas	He has been in prison for 30 years, he has not been disciplined or released for saying "mr. Ocalan".
85	Nasrullah Kuran	For 30 years, a man has been imprisoned in Imrali prison alongside Abdullah Ocalan. Because he says "Mr. Ocalan", he is not disciplined and released with his execution on fire.

## **Conclusion and Claims:**

As The Centre Kurde des Droits de l'Homme, we have come to the conclusion that deaths due to illness and suicide are suspected in prisons and that pressure, torture and undemocratic practices in prisons should be investigated.

We request an investigation commission affiliated with the United Nations High Commissioner, we call on the UN rapporteur on the fight against torture to show particular interest in prisons in Turkey.

We strongly demand a visit to prisoners in Turkish prisons, especially for Kurdish prisoners who are imprisoned for political reasons, and take measures against the UN High Commissioner and his relevant units.

Finally, during the preparation of this report, there had to be an update to the list, as two other Kurdish prisoners as "died" suspiciously within 48 hours. This happens in daily basis under the Turkish regime, where thousands of political prisoners taken hostage, facing torture, degrading behaviour and the constant threat of death.

We urge the OHCHR to take steps to investigate the situation immediately, since the primary objective of OHCHR is to "work to protect all human rights for all peoples".
